

3 The expenditure involved is debitable to Demand No.63 Law and Justice during 2005-2006 under Major Head 2014 Administration of Justice Minor Head 00.105 Civil and Sessions Courts, 06 - Fast Track Courts (FTCs) Object head 06.00.31 Grants in aid Non-Plan).

4. The concerned State Government is requested to utilize this amount during the current financial year 2005-2006. The details of the amount spent by the State Govt. alongwith audit certificate, utilization certificate in the prescribed format duly signed by the competent authority and physical achievements may please be sent to this department at the earliest & latest by the end of the stipulated period in this regard.. If the fund allocated is not utilised within the prescribed limit the same should be surrendered at the earliest.


